PC&PNDT Act State Advisory Committee meet held

Gangtok, May 11: The State Advisory Committee of the PC&PNDT Act met in the chamber of the DG-cum-Secretary, Dr.D.K. Bhandari who is also the Chairperson of the Committee, today. During the meeting, it was decided that NOC for private clinics USG users is mandatory from the organisation they work in. Also, NPA is mandatory for USG users of government organisation. Further, it was informed that a PNDT Cell has been established with proper manpower available for its smooth functioning. Also, a State inspection and Monitoring Cell is now in

place which will conduct inspection of clinics with USG facilities on a monthly basis. Dr. Bhandari asked the committee members for further suggestions that would help in strengthening the Act within the State. He further said that the declining child sex ratio is a cause of concern and hence requires strict implementation of the PC&PNDT Act in the State. The meeting concluded with Dr. Bhandari laying stress on the need for training of the gynaecologists and medical officers as USG service providers. (IPR)

Former Bengal governor Gopal Gandhi may be opposition's choice as presidential candidate

Kolkata, may 11: Mahatma Gandhi's grandson and former governor of West Bengal Gopal Krishna Gandhi may emerge as the opposition's candidate in the upcoming presidential election that will be held in July. Gandhi's name has come up in internal discussions of opposition parties and according to a news report, preliminary discussions with him have also taken place. In a rare show of unity, arch rivals CPI(M) and Trinamool

Congress, which has more than 64,000 votes, are also backing Gandhi's candidature. "Gandhi will be the first and possibly the only choice for Mamata (Banerjee). She had earlier battled for Gandhi as the vice-president candidate," sources close to the West Bengal chief minister told the Hindustan Times. Banerjee is scheduled to meet Congress president Sonia Gandhi next week to chalk out the strategy for the presidential election. Banerjee,

who enjoys an excellent personal rapport with Gandhi, will arrive in Delhi on Monday and is likely to meet the Congress chief on Tuesday. Trinamool Congress' votes are crucial for the opposition to give a close fight to the Bharatiya Janata Party (BJP). The left parties have already proposed Gandhi's name to the Congress leadership. Top opposition sources told HT that when CPI(M) leader Sitaram Yechury met Odisha chief minister Naveen Patnaik last week in Bhubneshwar, Gopal Gandhi's name was also mentioned during the discussions. Gandhi, an eminent scholar and a former civil servant, was appointed as the governor of West Bengal during the United Progressive Alliance (UPA) regime. He was India's ambassador to South Africa and some other countries. The son of Devasdas Gandhi also enjoys a clean image. Gandhi's candidature, however, is not final as the Congress president is yet to complete discussions with different opposition leaders. One opposition leader also pointed out that although Gandhi is an ideal candidate with excellent credentials, he may not be able to garner votes from the National Democratic Alliance (NDA) camp like Nationalist Congress Party (NCP) chief Sharad Pawar.

West Bengal govt to High Court: Probe into Bhangar killing nearing end

Kolkata, may 11: The Calcutta High Court was on Thursday told that the probe into the death of a person due to gunshots during a stir in South 24-Parganas district was at its last stage and the CID would soon identify the persons behind the killing. The West Bengal government conveyed this information to a bench of Justice Joymaloy Bagchi through Advocate General Kishore Dutta. Justice Bagchi had earlier expressed displeasure at the lack of progress of investigation into the death. Dutta told the bench that the sleuth hoped to inform it about the identity of the persons behind the killing on the next date of hearing. Justice Bagchi observed that the report submitted by the CID on the progress of investigation was vague and suffered from opaqueness. Additional Director General (CID) Rajesh Kumar appeared before the court today on a direction by Justice Bagchi to apprise him on the progress in the probe. Representing the ADG, the advocate general

submitted that the investigation by the CID into the killing of a person during the agitation over building of a power grid sub-station at Bhangar in South 24-Parganas district in January this year was at its last stage. During the last hearing on April 26, Justice Bagchi had expressed displeasure at the CID's failure to arrest the person involved in the killing of the man and had directed the ADG CID to appear before him to explain the progress in the investigation. Father of Mofizul Khan, who had died of gunshot wounds at Bhangar on January 17 during an agitation over setting up of a power grid sub-station, had moved the high court subsequently seeking a probe into the death by an independent agency other than the state police. Khan's counsel Jayanta Narayan Chatterjee had prayed for a probe into the killing by an independent agency other than the state police or CID, claiming before the court that the victim died in firing by the police.

As religious leader, have right to use red beacon: Kolkata imam

Kolkata, May 11: Defying the Centre's ban on use of red beacons, the Shahi Imam of Tipu Sultan Masjid, Maulana

Noor-ur Rehman Barkati today said he is not bound by the order and as a religious leader, using it was his "right." "I am religious leader and I have been using the red beacon for past several decades. I don't follow the orders of the Centre. Who are they to order me? In Bengal, only the orders of the state government are effective. I will use red beacon. In Bengal, no one has removed red beacon," Barkati told PTL. Seeking to end the VIP culture, the Union cabinet had decided that red beacons would be removed from all vehicles + ,

including that of the prime minister+, from May 1. The state BJP came down heavily on the Imam for defying the Union cabinet's order. "From where does he get the audacity to defy the decision of the Union government? The state government should immediately take action against him. Only being from the minority community does not give him the right to do whatever he wants to," said state BJP secretary Locket Chatterjee. The Kolkata police denied to comment on the matter of Barkati using the red beacon and said it was "not aware" of it.

Bengal govt upbeat on new IT parks

Kolkata, May 11: West Bengal government today said it remained optimistic on seven new IT parks in the state despite job loss threat looming on technology companies over H1B visa crisis. "We have 13 IT parks currently and we are going forward with seven new parks," state IT minister Bratya Basu said at a seminar organised by Bengal National Chamber of Commerce & Industry (BNCCI). The crisis of H1B visa was not yet felt in West Bengal and no major IT companies in the state had approached the government on retrenchment, he said. Basu said that if the latest round of auction for Sonarpur hardware park failed, the IT ministry would try to reduce the price of land.
